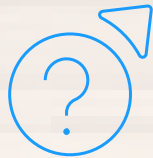

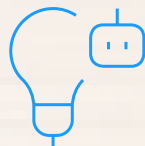
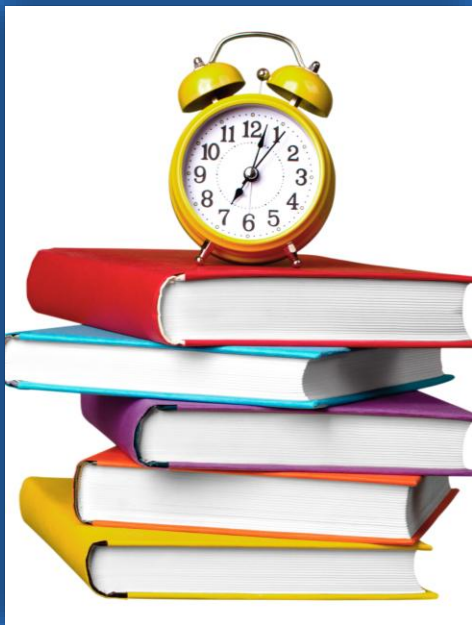

Risks Introduced by AI

Potential for Cheating

- Ensures exams are closed book.
- Use AI detection software.
- Provide clear guidelines on AI use.



Overreliance on AI

- Apply critical thinking to AI output.
- Ensure exams are closed book.

Inequities

- Candidates who have access AI powered tools can have an unfair advantage.

Addressing Other Challenges

Addressing Hallucinations

- Use the latest models.
- Use reasoning models for math.
- Provide relevant context in the prompt.
- Cross reference with other materials or models.



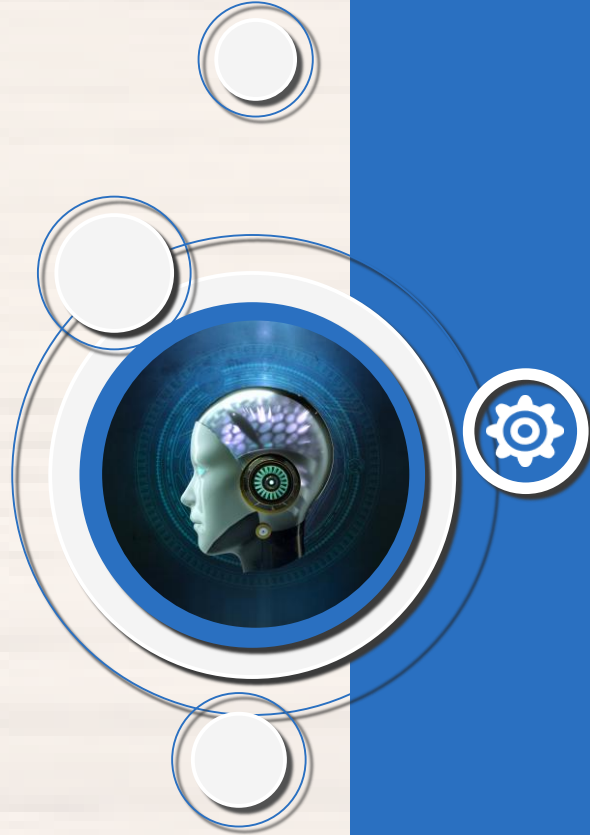
Building Trust

- Understand that, just like humans, AI will not be 100% accurate.
- Get familiar with AI's strengths and limitations.

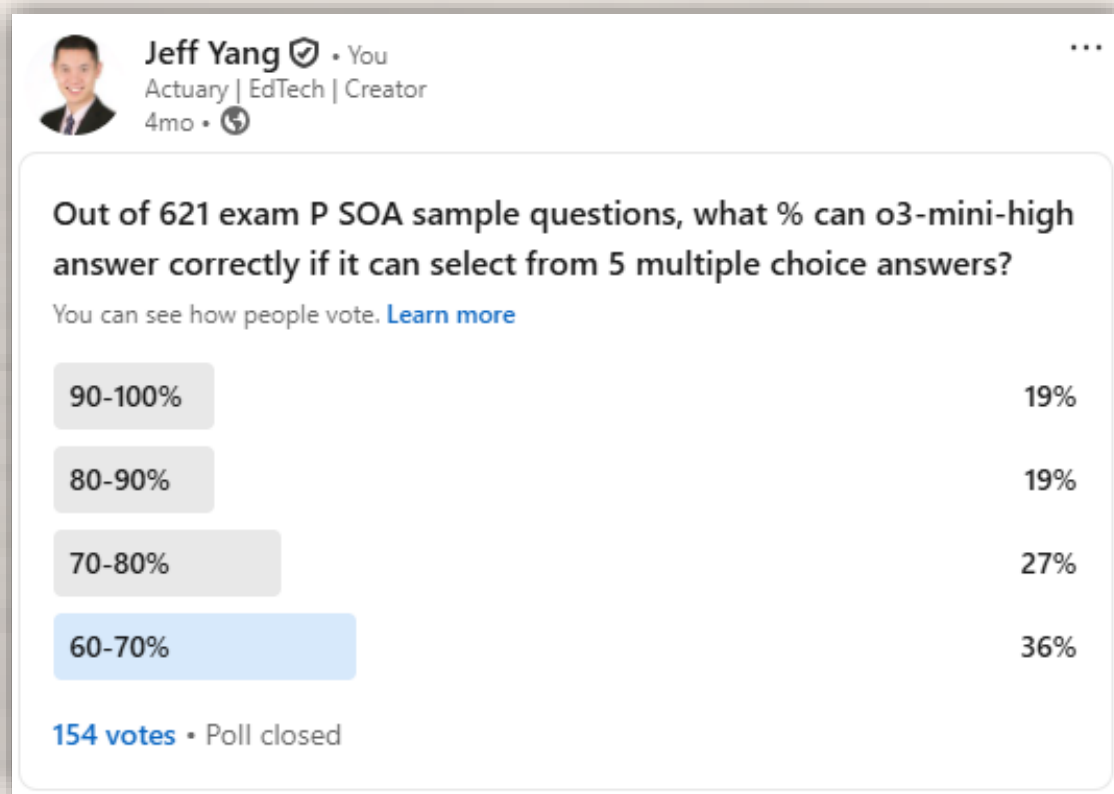
Adapting to Evolving Technology

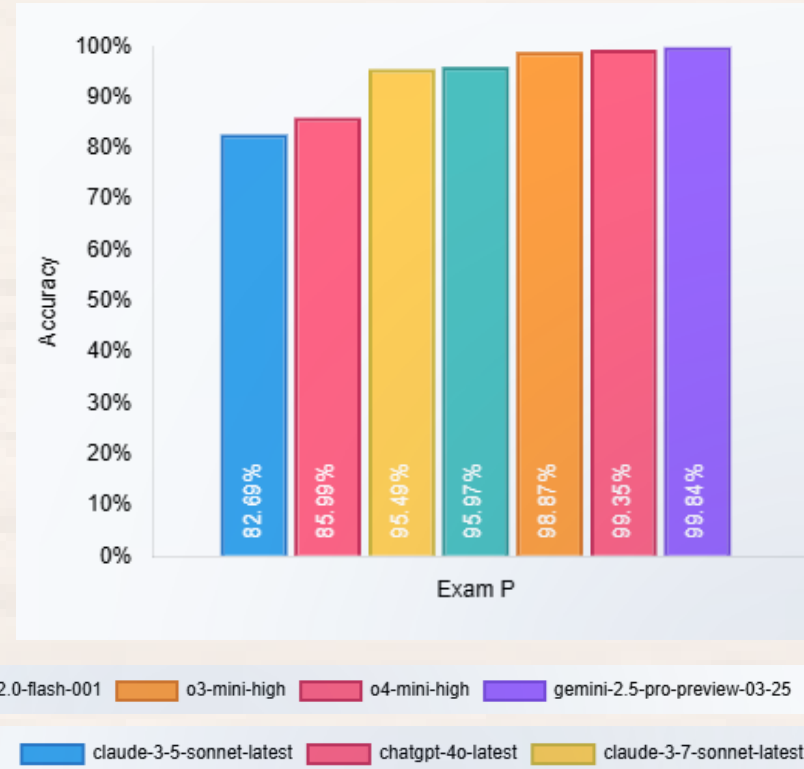

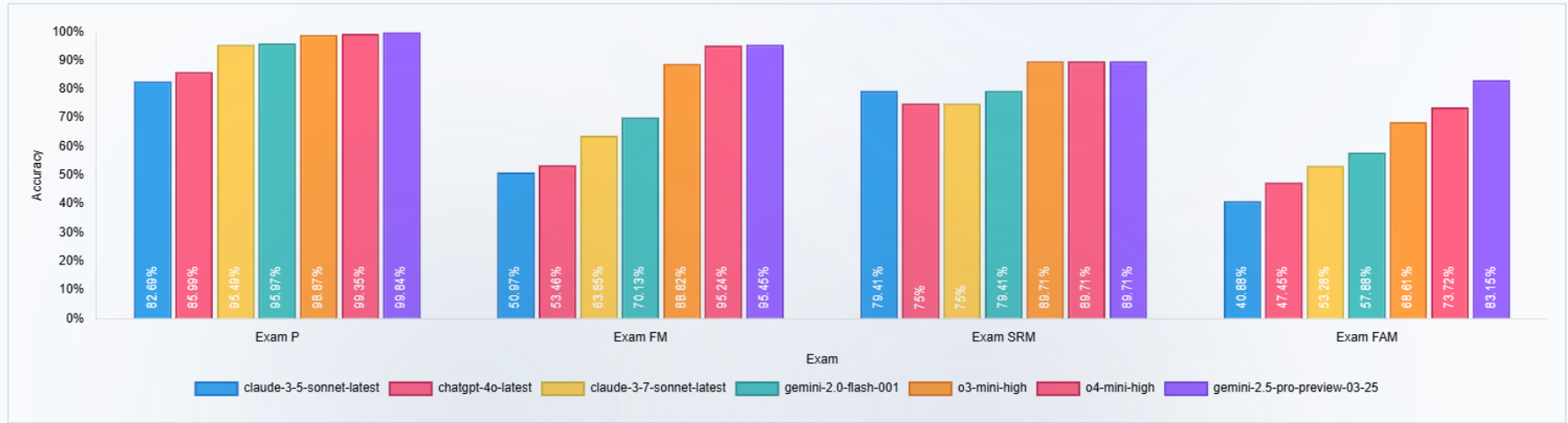

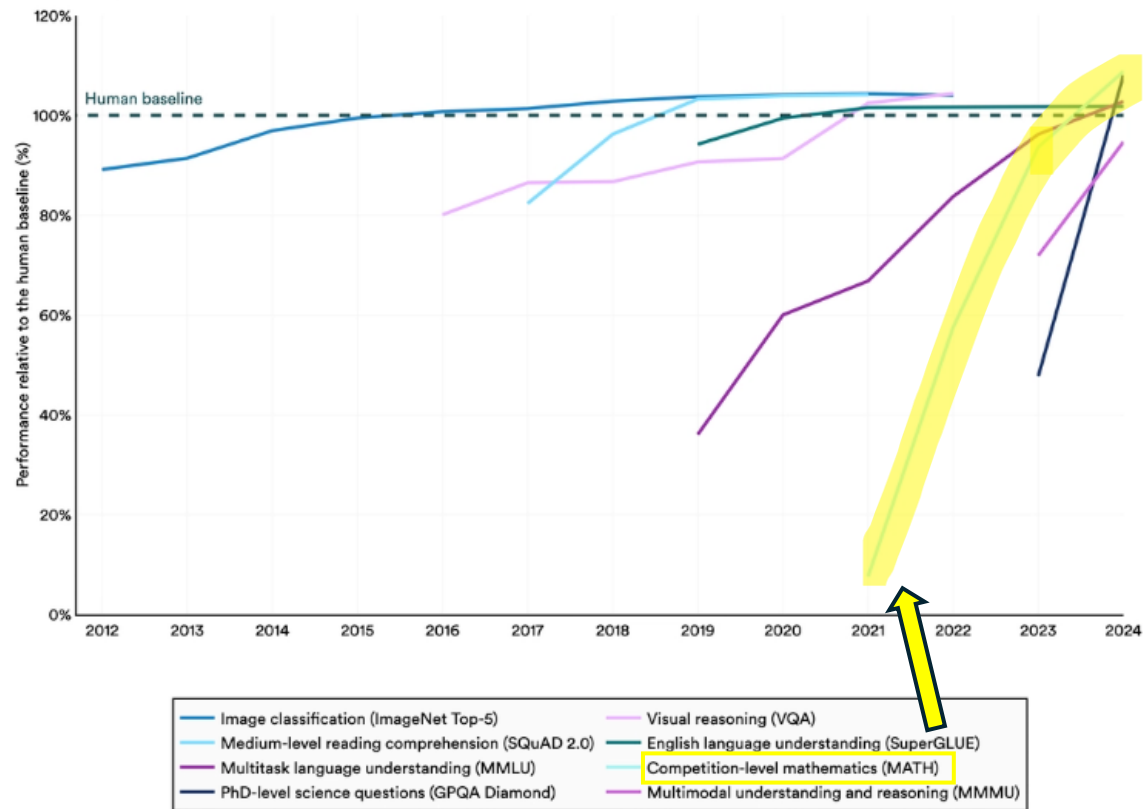

Other AI Improvements

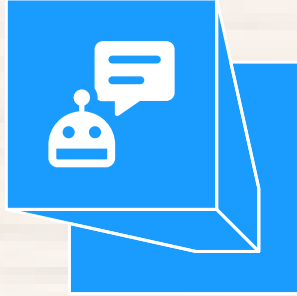
- Enhancements in context windows, compute, speed, and cost

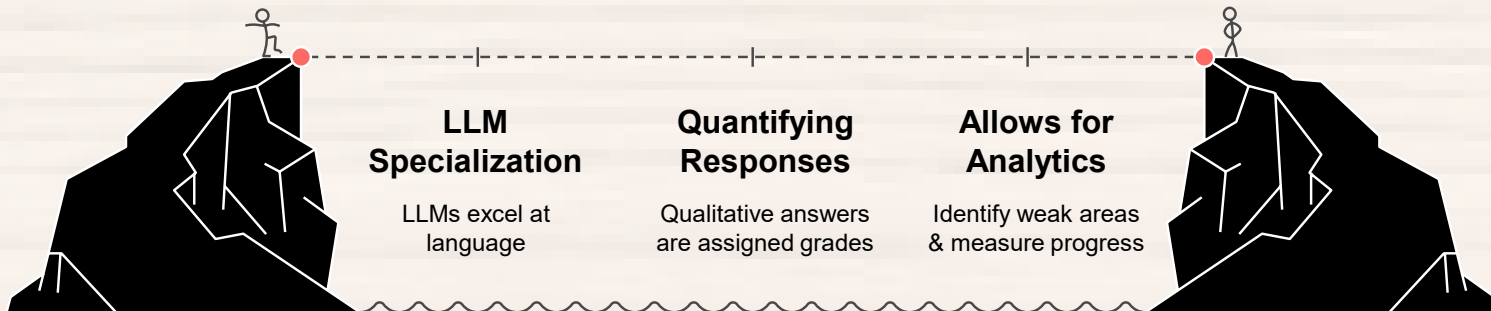
